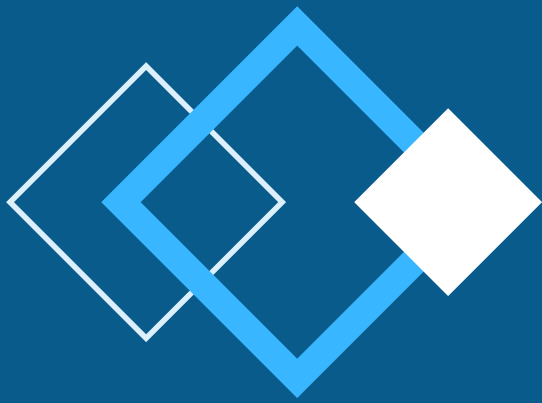

WELCOME MESSAGE

Patricia F. McCartney, National President SSVP Scotland

It is with honour that I write this annual report, my first as National President having been appointed in June 2024. I begin by expressing my sincerest thanks and appreciation to all our members, volunteers, staff and benefactors without whom we could not serve those we do. The hours and the personal sacrifices made and the commitment given to the Society by members and volunteers is truly commendable. However, as our meeting prayers remind us '.....never to claim that our works spring from ourselves alone...'. We are therefore truly blessed and privileged to do what we do in Christ's name and for that, grateful thanks and praise is given.

SSVP SCOTLAND INTRODUCTION

The annual reporting period of 1st April 2024 to 31st March 2025 was a time of considerable change and challenge for the Society of St Vincent de Paul in Scotland. In particular, this period saw a number of comings and goings at trustee, national council and national office level. Danny Collins stepped down as national president in June 2024 and James Heneaghan, the national treasurer, followed in August 2024. Following a relatively short period of illness, Haydn Carr-Pollock, Archdiocesan President for St Andrews and Edinburgh, sadly passed away in January 2025. He was our youngest Trustee / Diocesan President with so much to give to the Society. He is greatly missed. Our thoughts and prayers remain with Haydn's family. Due to reaching the end of their terms of office other Trustees / Diocesan Presidents stood down. Only one of the original group of Trustees / Diocesan Presidents that started in the reporting year of 2024 continued in office by end of 31st March 2025. The dioceses of Argyll & Isles and Galloway remain without Presidents.

The SSVP Scotland National Council also experienced a change in the voluntary roles of Twinning and Social Justice Coordinators as new appointments were made to replace the previous members. Family and career commitment also lead to the departure of Sean Murphy, the volunteer National Student Coordinator. Sr Maria Robb continues to remain as our Spiritual Director and for that we are truly thankful.

The National Office was significantly impacted in this period as Jacqueline Laird, Office Manager for eight years left in December 2024 following a period of long term sick. Appreciation and thanks is given to her service to the Society. However despite these challenges it also offered opportunities to review existing ways of working and examining our structure. We continue to serve in hope!

OUR STRUCTURE

The Trustees/Diocesan Presidents, members, volunteers and employees at the national office are the backbone of the Society. They enable the charitable works the Society carries out throughout Scotland to continue to be delivered to those most in need.

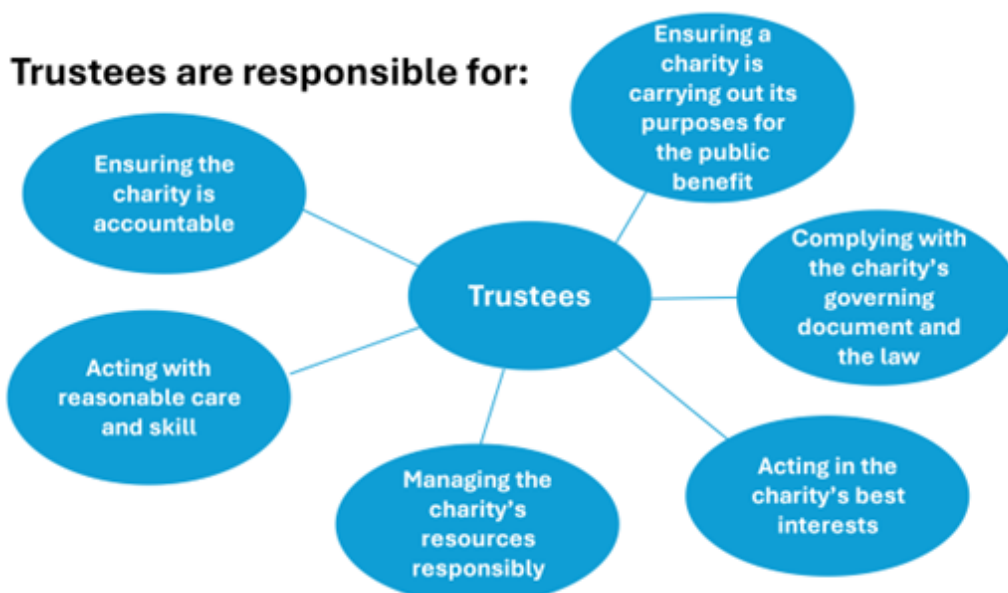
The organisational structure of SSVP Scotland is designed to ensure effective governance and decision-making whilst also ensuring the ethos of the Society - 'that it serves those most in need'. There are 3 'arms' of the Society. These are the SSVP Scotland:

- Board of Trustees
- National Council plus Diocesan Councils, Groups Conferences and Special Projects
- National Office



SSVP Scotland Board of Trustees

SSVP Scotland's Board of Trustees comprise the National President, National Treasurer and eight diocesan presidents.



National Council

Led by the National President and National Treasurer, the Council consists of the Trustees and National Coordinators focusing on areas such as twinning, social justice and youth.

The role of Diocesan Presidents on the National Council is to be the link both to and from Diocesan Councils / Groups / Conferences. This is to ensure local needs are addressed while aligning with national strategies



The National Office

The National Office oversees key functions regarding compliance, conference membership and the financial management of the Society. It is staffed by a small team supported by a handful of dedicated volunteers who help assist with administration and other ad hoc business.



OUR WORK

The SSVP members form and meet in local groups known as *conferences* to provide assistance and support to those in need. In addition a small number of special projects also operate e.g. furniture projects, holidays and clubs / centres. Due to the dedication of our members, 2024/25 was a good year for the Society of St Vincent de Paul in its key areas of charitable activity.

Companionship & Support

Many aspects of our Vincentian work involves companionship and reducing isolation. This includes visits to people in their homes, taking people out for a 'cuppa', to mass, accompanying people to hospital appointments, hosting lunches, organising outings, running breakfast clubs, and trips to the pantomime and cinema.

Furniture and Material Support

There are three furniture projects operating in 2024/25. A further two projects are in development. In addition to providing furniture and white goods, food vouchers/parcels and energy relief is also offered where there is the added need.

Holiday support

Three dioceses offer holiday provision and continue to assess the need and related cost. St Andrews & Edinburgh Archdiocesan Council continue to operate two caravans. Although not operating caravans, Motherwell Diocesan Council review the need locally within Conferences. Glasgow Archdiocesan Council continues to offer a dedicated Holiday Fund.

Ozanam Clubs and Centres

During 2024/25, with increasing demands on social services, the work of both the Ozanam Centres and Ozanam Clubs continues to be vital. The Ozanam Centres reliably continue to offer food, clothing and befriending to homeless people. The Ozanam Clubs maintain an equally important need offering a range of recreational services to both adults and children with special needs.

Support for Overseas

Twinning

SSVP Scotland through its conferences continues to 'twin' successfully, in both South Africa and India. Overseas aid by conferences continues at £40 quarterly. We have 262 Twins in India and 100 in South Africa. We also fund approximately 8 individual Projects. These are separate to Twins and currently only apply in India. Some SSVP Scotland conferences also support the Educational Sponsorship Scheme for Indian students. This scheme supports students during the course of their studies.

The Educational Sponsorship Scheme for Indian students and the Project Scheme help many people and change lives. For example, the purchase of 15 sewing machines for 15 women, at a cost of £925, plus a local contribution of £90 enabled these women to provide an income for their family.



SSVP Commission for International Aid and Development (CIAD)

The SSVP Council General International Commission for International Aid and Development (CGI CIAD), and Fund for International Solidarity (FIS), consider how best to assist SSVP members supporting the many disasters and emergencies around the world. It is a concern shared by SSVP members in Scotland. During 2024/25 an area of particular concern was Myanmar. During 2024/25, £14,471 was sent to support the FIS, with £3,500 allocated to Middle East FIS.

The SSVP Youth programme

In **Motherwell Diocese**, the annual Youth Pilgrimage to Carfin Grotto was a great success. This year, over the course of 3 days we were joined by 32 schools from across the diocese. This equates to around 50% of our Catholic schools with over 600 children being involved in Mini Vinnie Conferences across Motherwell, and more schools coming on board weekly. The SSVP was delighted to once again welcome Bishop Toal, who led the Rosary Procession on the first day. We were



also supported by Parish Priests and Deacons who participated and interacted with the children in their various activities. The commitment and enthusiasm of these young people to put their 'Faith in Action' is truly inspiring and it was also encouraging to see so many Conference members from across the diocese attending these events. However, we cannot forget the teachers whose commitment and dedication in supporting the Mini Vinnies is invaluable – a huge thank you!

In **Glasgow Archdiocese**, teachers and children of St. Mary's primary school in Duntocher, Clydebank presented a cheque to their local SSVP conference. The children had raised a fabulous total of £1,000 to be donated to two charities chosen by the children. A fund-raising day was held in the school with tea and



coffee served to all who came to buy goods from the many stalls on offer. Fair trade and The Saint Vincent De Paul society were the grateful recipients of the funds raised. The donation helped the SSVP to support over 40 families in the local area.



In **Galloway Diocese** a Caritas student, aged 18, from St Matthews Academy in Saltcoates with an SSVP member, visited a bereaved gentleman. They listened as the gentleman spoke with enthusiasm about his hobby of photography. As a result, they have since accompanied him on several outings to take photos. This has been of immense mutual benefit, giving great pleasure to the gentleman and learning for the student.

Newsflash : In March 2025 , the Trustees approved the appointment of National Youth Development Coordinator to take up this full-time paid post in April 2025.

Social Justice

Collaboration with other charities which share the same ethos and values of SSVP Scotland continues to be strengthened and developed.



Support for Prisoners

Liturgical Items

During November and December 2024, the SSVP, in cooperation with Catholic Chaplains in Scottish prisons, launched a scheme to donate liturgical items to prisoners in Scottish prisons. The items included rosary beads, prayer cards, books and missals. The response was overwhelming, to the extent that the appeal closed after only a month. Deacon Kenny McGeachie, the adviser to Catholic chaplains, was delighted with the result. "The response has been wonderful. It is so good to be cooperating with the SSVP in this way. I hope it is the beginning of future fruitful collaborations," he said.

The Dignity Fund

On 27th March 2025 the Society signed 'The Prisoners Week Charter' and committed to provide the annual sum of £5,000 to the 'Dignity Fund' being the first organisation to commit to this newly established fund.

The Dignity Fund was set up by Prisoners Week Trust (PWT). PWT is a registered charity (SC043431) which holds its own bank account and has an appointed Treasurer who works within the charities governance structure and is separate to Scottish Prisons Service (SPS).

The purpose of the Dignity Fund is to support individuals in prison who are in need of essential items and who do not have the means to purchase these. The fund can also provide small grants up to £20 deposited directly into a person's prison account (PPC) through the existing SPS facility 'Sending Money'.



The Dignity Fund

Approval by the SSVP Trustees to support this fund was a result of a series of meetings and discussions between Deacon Kenny McGeachie, the National Catholic Chaplain for the Scottish Prison Service and SSVP Scotland (led by Honor Hania, SSVP Social Justice Coordinator with input from SSVP National President). These meetings led to a detailed paper being presented to the SSVP Trustees. This outlined the rationale for and how the fund would be used and was backed up by a presentation and question and answer session by Deacon Kenny McGeachie.

The paper proposed the request of an annual sum of £5,000 from the SSVP Scotland to support this fund. Recognition was given to the stipulation that the SSVP is prohibited from donating to other charities, but that trustees can override this prohibition in exceptional circumstances. Support for those in prison is a scriptural imperative (Matthew 25:31-46), and was identified as a main aspect of the society's social justice activities (Annual Report, 2023-2024). It was thus agreed that the support for the Dignity Fund is one of these exceptional circumstances due to the restrictions imposed by SPS on the donations of items directly to prisoners due to security risks.

How the fund works:

The Dignity Fund has set up a thorough procedure for the application for grants.

The fund is very limited in the number of grants available. However, it is hoped to increase this over time. Currently, grants of up to £50 may be awarded. Applications are made through the Chaplain to cover essential items where the individual does not have the money or means to provide for these. Only one grant per person may be made.

- A need is identified which is either:

a. an item or items up to the value of £50, required for a specific purpose such as a funeral, court appearance or release e.g. pair of shoes, white shirt, black tie.

OR

b. financial support for small essential items up to the value of £20

- The Chaplain checks the persons PPC to confirm their suitability for accessing the Dignity Fund i.e. they do not have their own resources.

- Purchase of items up to £50

a. the Chaplain purchases the authorised item(s) and retains receipt

b. the Chaplain arranges for the item(s) to be placed in a persons property or for general reception use.

c. the Chaplain sends the receipt via scan, along with banking details, to the PWT Treasurer for reimbursement.

- Deposit in PPC up to £20

a. Once the application is approved the requested amount will be deposited by the PWT Treasurer in a persons PPC through the SPS online fund.

Glasgow Diocese

Frederic Ozanam Scholarship.

The success of the Frederic Ozanam Scholarship Fund continues. This initiative, started in 2018 enables pupils of any denomination in 12 Catholic secondary schools in the Glasgow Archdiocese to benefit from financial assistance whilst at university. Priority is given to pupils who, because of financial hardship, would not be likely to embark on a university education. The assessment criteria are based on: the financial situation of the applicant's household; academic achievement; work experience; extra-curricular activities and achievements.

The scholarship awards the sum of £1,500 per successful applicant to be payable in each year of their chosen degree course, dependent upon the applicant's acceptance onto the next year of the course. Payments are made in 3 stages, £700 prior to the start of the first term, and £400 prior to the start of the second and third terms. The scholarship which was originally piloted with 2 pupils in 4 secondary schools has now been extended to 12 of the 18 Catholic secondary schools for subsequent academic years.

To date, the following scholarship awards have been made:
5 for the 2019/20 academic year;
5 for the 2020/21 academic year;
3 for the 2021/22 academic year;
0 for the academic year 2022/23
(effect of pandemic on affordability);
3 for the academic year 2023/24;
8 for the academic year 2024/25.

To date, 7 of the 24 successful applicants have graduated. Many of these have praised the scholarship, giving testimony to how it enabled them to successfully complete their degrees.

"This scholarship has been incredibly helpful during my university experience. Especially when starting my first year, I needed to buy things like new laptop for my course and I couldn't have done so without this. University is time consuming therefore it is often hard to balance a part-time job as well as doing well in your course, knowing that you're getting financial help takes a lot of pressure off. It is amazing that scholarship like this one offer so much help for students who really need it. I am forever grateful for this help." – Alexandra (2019/20 awardee).

"In my first year of university my scholarship allowed me buy a laptop that I could use in the lectures and tutorials. This laptop became crucial in the next two years when I had to study from home. It also allowed me to completely focus on my studies as I did not need to get a job in order to pay for things like travel, lunches and textbooks. I am extremely grateful for this scholarship as it has benefited my studies greatly." – Calum (2019/20 awardee).

"The Frederic Ozanam Scholarship has been very beneficial to me during my studies at University as it has allowed me to have an increased financial stability and focus on my education rather than having the burden of part time jobs as part of it. Being a student nurse also it has helped me get resources and equipment to better equip myself for the world of work and during nursing school also. I am forever grateful for this wonderfully opportunity." – Oluwatosin (2019/20 awardee).

Dunkeld Diocese

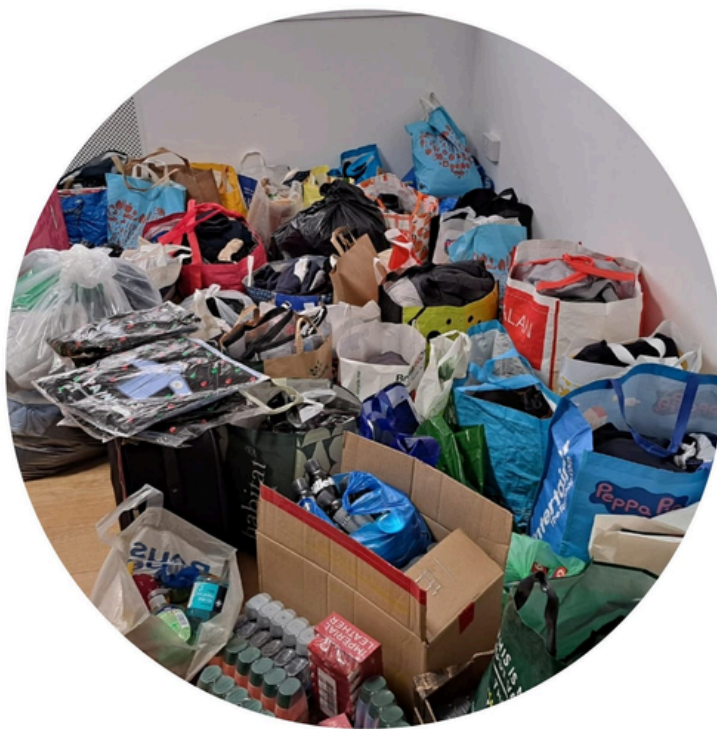
In Dunkeld, collections were taken up for clothes for refugees. The Perth conferences, working with the local Food banks, have purchased food vouchers from local Halal food suppliers. This means that rather than give food that is not appropriate, families looking for Halal food receive vouchers and go and collect what they need.

With support from a Dundee businessman, Dunkeld Conferences now have access to facilities where we can store furniture to help needy families. In the last 12 months we have supplied furniture to over 18 families or individuals.

The 2024 SSVP Annual Meeting was held in the Radison Hotel, Perth. Due to the hotel being used to accommodate refugees it was agreed that the recipient of the offertory collection money would be the local centre who supports refugees in that area. A total of £958.57 (including a cheque of £500) was donated. In addition members attending the meeting also donated a large selection of toiletries and clothing.

Motherwell Diocese

A Journey of Renewal and Revitalisation

During 2024/25, Motherwell Diocese embarked on a consultation exercise with all conferences within the diocese to obtain their input into the way forward for the society in the Diocese of Motherwell. Many positive comments and good practices were identified as well as many weaknesses and challenges. The Diocesan Council welcomed all feedback and used this as the catalyst to launch a Renewal and Revitalisation Action Plan. The plan focused on the key priorities of:
Increasing/ strengthening membership; Improving Communications;
Embracing our Spirituality; Development of Mini Vinnies / Senior Vinnies Groups
Special Projects

A Diocesan Outreach Mobile Conference was set up in November 2024. The purpose was to adapt to a changing world and new forms of poverty by developing an Outreach Programme enabling the Society and its services to be more accessible to those in need of help and support throughout the diocese particularly where there is no SSVP Conference in local parishes. The aim is to tell people Who We Are, What We Do, How We Can Help. We were warmly welcomed by parish priests and parishioners. One of the parishes visited since set up a new SSVP Conference!

Bereavement Parcels - St Aloysius Chapelhall

As part of our role as members of the Society of St Vincent de Paul, we have discussed and considered how we can best support those in our community who most need it. This led to the introduction of **bereavement parcels**, which we have now been doing for almost 10 years. While the loss of a loved one can be a very difficult time emotionally, it can also be a challenging time financially. We wanted to support our parishioners during this time, so we introduced bereavement parcels containing bread, butter, meat, cheese, tea, coffee, milk, biscuits and sugar. And when appropriate, mass cards and sympathy cards are also given.

This is something we do for all members of the community regardless of religious denominations and backgrounds. There has been a great response to this, with many people expressing gratitude for how much our support meant to them and the comfort they received knowing we were thinking of them and their loved ones. Many outside of the chapel's community have been shocked when receiving parcels, as they did not expect such support would be extended out with the parish community. However, at these difficult times we feel it is important to show our care and help where we can. The kind responses and gestures we have received back from the receivers have been moving, with many reaching out to send thank you cards. Some of which also contain donations for the society. Overall, the parcels have acted as a way to bring people together during times of such loss and are a reminder that we are all one local community.

Paisley Diocese

Holy Spirit Special Works Conference

This conference supports the Jericho Brothers who run two homes for recovering drug addicts, one for men and one for women. This support includes;

- Supplying and maintaining two minibuses and meeting the running costs (insurance, road tax, fuel etc.).
- Providing drivers for the minibuses, to enable the men and women to attend Narcotics Anonymous meetings every night.
- Helping with the purchase of furniture and fittings for the homes.

St Vincent's Hospice Special Works Conference

Helps the Hospice fund special projects that have been approved in advance by the conference, e.g. furniture for bedrooms, therapy rooms and day room and improvements to the general décor of the Hospice. In the last year £25,400 was made available for these.

Our Lady of the Wayside Special Works Conference

Run a soup kitchen on a Friday night, serving a three-course meal to an average of 15 men and women. They also operate a clothing store which conferences can call on to obtain clothing and bedding (for men, women and children). A food distribution service (which they started during Covid) continues to grow, with food parcels going out to conferences and schools on a weekly basis.

The Ozanam Club

Organises a social club for adults (16+) with additional support needs, on the 2nd and 4th Fridays of the month. A typical night involves games, puzzles, carpet bowls, Karaoke and a disco. The Club has recently purchased a basketball game with an electronic scoreboard which is proving popular with the members. Throughout the year we have special party nights, Halloween, St Andrew's Ceilidh, Christmas Dinner, St Patrick's Ceilidh and a Summer Party.

Furniture Project

In the last year, we have carried out 106 collections and 132 deliveries of furniture. Before a delivery, the local conference will visit the person looking for furniture and assess what is needed.



St Andrew's and Edinburgh Diocese

Caravan Project

This project in St Andrew's and Edinburgh continues to thrive, with many families benefitting from a well deserved holiday every year. Uptake has been really high.

Furniture Project

This project continues to thrive, with a constant turnaround of good quality furniture. We also supply and usually fit washing machines and fridge freezers, always tested before installation. Drop-offs take place twice weekly.

Pro Ecclesia et Pontifice Award

SSVP member Richard Steinbach was given the Pro Ecclesia et Pontifice Award from Pope Francis, for services and dedication to the Society of St. Vincent de Paul, and the Archdiocese of St. Andrews and Edinburgh. His Grace, Archbishop Leo Cushley presented the award.

In the Diocese of Argyll and the Isles, our conferences in Campbeltown and Oban continue to reach out and serve those in need.

In the Aberdeen Diocese, the 59 members across 11 parishes, also continue to serve those in need.

SSVP SCOTLAND ANNUAL MEETING

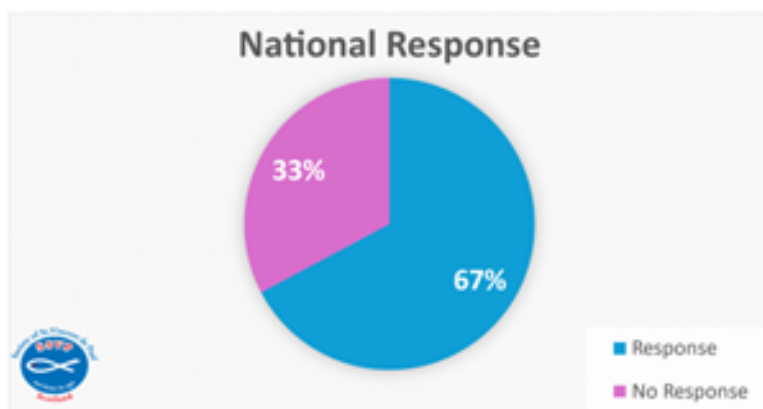
The Society of St Vincent de Paul (SSVP) Scotland held its Annual National Meeting on August 31, 2024, under the thought-provoking theme, “Where are you?”. A key aspect of the meeting was to take a hard and critical look on the Society’s current status and to reflect and share information on membership demographics, and the ways in which the Society engages with modern technology.

Outcomes and Positive Steps

In response to the call of ‘Where are you?’ a small working group of initially five interested members volunteered to assist and support the trustees. They came forward to offer their skills and expertise from a wide and varied background for the benefit of the Society, representing four different dioceses. As other priorities are identified more small working groups will be needed to expand on what is already being done. To date areas given priority attention have been researching the prospect of digital giving; the creation of new roles within the national office; development of values, a vision and mission statement and a business plan. This work will be continued in the next reporting period.

Membership Insights

In preparation for the national meeting, a National Members Survey was conducted to gather vital data on conference membership, including the number of active members, age profiles, and their usage of technology such as email, Zoom, WhatsApp, and social media platforms.



Based on the percentages of responses received and the data held by the National Office this information revealed significant statistics about SSVP Scotland's structure and membership:

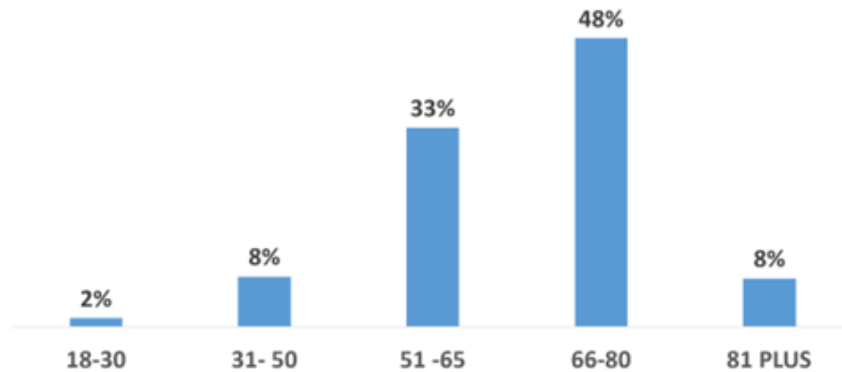

Age Profile

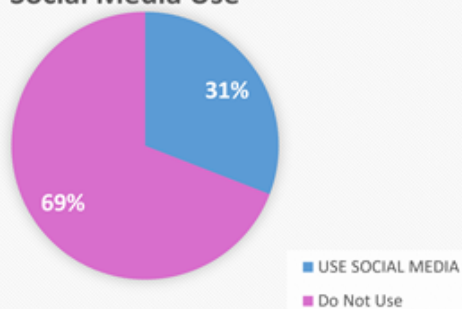
SSVP Members Age



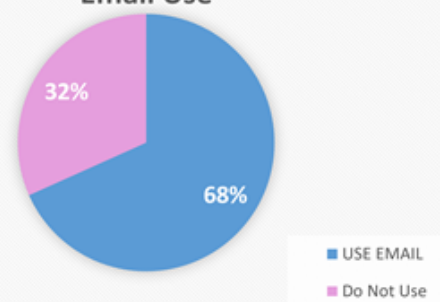
Technology Usage

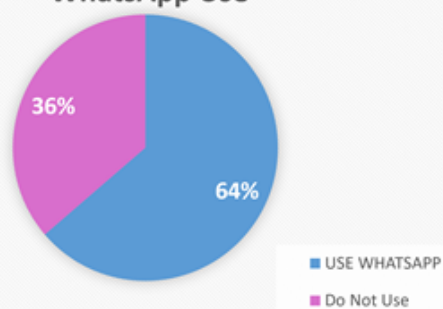
Social Media Use



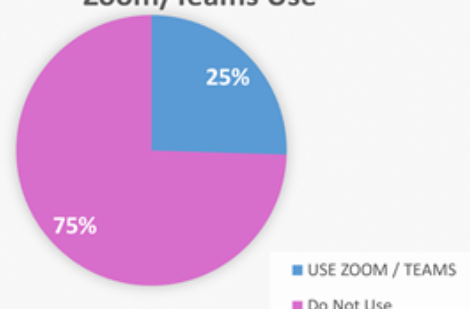
Email Use

PLANNING FOR 2025/2026

Approval was given to appoint a National Youth Development Coordinator to lead the process of developing, embedding and monitoring an innovative new strategy for SSVP Youth Development in Scotland. The key role and responsibilities are the promotion, development, support and coordination of SSVP youth work throughout Scotland, with key stakeholders, such as Diocesan Presidents, Diocesan Youth Coordinators, teachers, chaplains and youth organisation networks in Scotland.

The role of Office Manager will be replaced by a Finance / Administration Manager with more emphasis on accounts to ensure compliance for the Society's annual audit and to assist conferences with their annual returns. A part time book keeper to assist with payroll and invoices will be appointed to enable this to happen.

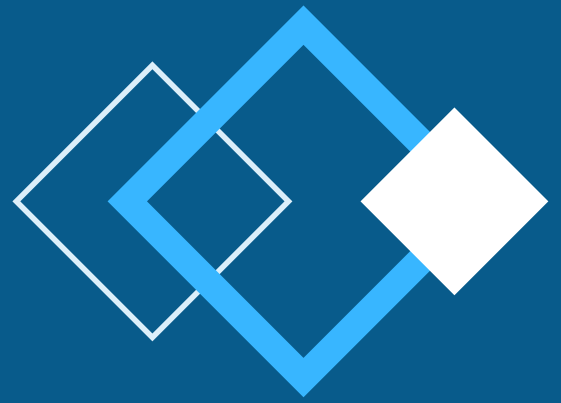
